### ABOUT SHUMIN

Shumin has an active disputes practice and is experienced in complex contractual disputes, shareholder's disputes, company law issues, and tortious actions. She also has particular experience with cryptocurrency and blockchain disputes, and freezing injunctions.

Shumin has acted for a wide range of clients from various industries before the Singapore Courts and in international arbitrations. This includes acting for industry leaders in the web3, retail, hospitality, and shipping industries as well as venture capitalists and high net individuals.

Shumin graduated on the overall Dean's List from the National University of Singapore and was placed fourth in the Singapore Bar exams. In the course of her undergraduate studies, she also obtained a University Degree in French Legal Studies from the University of Poitiers.

### EXPERIENCE

1. Lead counsel in an international arbitration acting for a stablecoin operator in a fraudulent misrepresentation claim, with more than USD 100 million in dispute.
2. Lead counsel in a claim brought by a leading stablecoin operator for fraud and breach of fiduciary duties, with the amount in dispute exceeding USD 450 million.

3. Lead counsel in a high-value, complex commercial arbitration involving issues of blockchain technology, acting for a web3 company and its founders in a dispute exceeding USD 100 million.

Lead counsel in urgent Mareva injunction proceedings for a private hedge fund against unknown fraudsters to prevent further dissipation of cryptocurrency, obtaining Singapore's first ever order permitting substituted service by NFT in a matter involving millions of dollars' worth of cryptocurrencies.
7. Lead counsel in a contractual dispute concerning the terms of a Simple Agreement for Future Tokens, acting for an infrastructure provider for decentralised exchanges in a matter exceeding USD 40 million.
8. Acted as lead counsel for Media Matters for America, a US media monitoring not-for-profit organisation, in successfully striking out a nearly US\$13 million defamation and malicious falsehood claim brought by Twitter Asia Pacific on the ground of lack of jurisdiction.
9. Acted for the Republic of India in an application to set aside an order obtained by Deutsche Telekom AG granting it leave to enforce a foreign investment arbitration award against India. The matter involved complex issues related to transnational issue estoppel (reported at [2024] 1 SLR 56).
10. Lead counsel in High Court proceedings successfully resisting an application for relief against forfeiture and securing the discharge of two injunctions preventing a landlord from re-possessing premises (reported at [2016] SGHC 90).
