### ABOUT ELMER

Elmer is a director of 2GO Group, Inc. and is the Corporate Secretary of SM Investments Corporation, SM Prime Holdings, Premium Leisure Corp., and other listed companies.

He also serves as Corporate Secretary of, and counsel to, premier industry associations, such as the Bankers Association of the Philippines and the Philippine Payments Management, Inc., the designated payment system management body of the Philippines, as well as the operator of the sole fixed income securities market in the country, the PDS Group.

Prior to joining the Firm in 2006, Elmer was a senior officer of BDO Unibank, Inc., handling investment banking, corporate finance and M&A. His extensive banking experience included a stint with Equitable-PCI Bank, Inc. from 1997 to 2002. He was a partner at the law firm of Oreta & Berenguer until 1995.

Elmer is a Certified Associate Treasury Professional and was among the top graduates of the Trust Institute of the Philippines in 2001.

### Corporate and M&A

- Played a key role in the investments of SM Investments Corporation and Chelsea Logistics and Infrastructure Holdings Corp. in 2GO Group, Inc., the largest integrated shipping, logistics and distribution company in the Philippines and recently, acted as transaction counsel to both parties in the purchase and sale of a controlling stake by SM Investments in 2GO Group, undertaking a mandatory tender offer for up to Php9.8 Billion.
- Advised Udenna Corporation on its USD980 Million acquisition of GGDC Holdings, an offshore company which indirectly holds the coveted leasehold from the Philippine government within Clark Freeport Zone, and in the USD690 Million financing for the project.
- Closed a pioneering cooperation and operating agreement for an integrated gaming and entertainment facility, now known as City of Dreams Manila, of listed Belle Corporation and Premium Leisure and Amusement, Inc. with MCE Leisure (Philippines) Corporation, an indirect subsidiary of Melco Crown Entertainment Limited, a company listed in the Hong Kong Stock Exchange.

The Firm challenged the PCC finding in probably the first adjudication by the PCC involving a merger review, resulting in a split decision of the PCC and the release of a clarificatory guide to computing merger notification thresholds.
