In addition to appearing in Court, Jonathan has also acted for clients in international arbitrations under the SIAC, ICC, PCA and UNCITRAL Rules.

Jonathan graduated from the National University of Singapore where he was a scholar. He represented the university in the William C. Vis International Commercial Arbitration Moot in Hong Kong.

#### Contract
